Conditions consist of 20 conditions divided into two pages and they represent one integral part of the application.

- 1. Create an entirely new global company called "World Gravity Motor"
- 2. The company brand "WGM".
- 3. The company's shares will be entirely for the inventor "Wisam Khalid Ibrahim".
- 4. We undertake to protect the funds belonging to the accounts of (the company and the owner of the company) that are located in banks within the country and will be delivered in full by banks immediately in case of a request from them and we pledge to transfer the funds belonging to (the company and the inventor "Wisam Khalid Ibrahim") freely without any conditions whether inside or outside the country and to the destination required by him or required by the company.
- 5. The headquarters of the company will be in the capital in an upscale area and all the costs to prepare the headquarters shall be paid for by the host country.
- 6. Obtaining a full tax exemption for the company and the owner of the company.
- 7. Work to facilitate the affairs of the company through full cooperation of the concerned ministries and departments of the State with the company and the owner of the company.
- 8. Giving the right to the company to build factories on the lands of the host country outside the capital without land rental fees.



- 9. The company's policy and decisions shall be determined exclusively by the owner of the company.
- 10. The owner of the company only has the right to choose the products and types of products that will be manufactured and/or marketed.
- 11. The Company has the right of manufacture and market products and patents and services which belongs to the company or which has been agreed between the company and other parties and the right of (agreement or disagreement) with other Individual or companies whether local and/or international and factories of other countries and within the Company's policy and decisions.
- 12. The host country will set up A full team of specialist employees to work at the company's headquarters to speed up the start of work
- 13. The host country undertakes to fully protect the headquarters of the company in the capital
- 14. The Company has the absolute right to employ persons of any nationality chosen by the Company or to cancel their employment and also The Company has the right to determine the amount of salary for each employee according to the company's policy and it's decisions only, without interference from local labor laws.
- 15. The Company has the right to establish local and/or international exhibitions to display the (Products/Patents/Services) which belongs to the Company or which has been agreed with other parties.
- 16. The company's products are for civilian use only, and no products will be produced for military use
- 17. We pledge to support the company in fulfilling global demand for its products and services through manufacturing and marketing and all other required efforts, and to protect the (company's and owner) intellectual property locally and globally.
